

# MECHANICAL Specifications

All ad materials should be submitted in digital format, designed according to the instructions outlined on the Mechanical Specs page below. For all questions regarding materials, contact the Production Department at [production@defensestandard.com](mailto:production@defensestandard.com).

## FORMAT

All ads must be submitted in a High Resolution PDF file format and submitted digitally. Submitted files must be no larger than 20 MB.

## SIZING

**FULL PAGE BLEED:** include a minimum of 1/8" to all edges past the trim

**HALF PAGE BLEED:** include a minimum of 1/8" to all edges

**THIRD PAGE BLEED:** include a minimum of 1/8" to all edges

**LIVE COPY AREA:** Keep copy to 1/4" INSIDE trim

**LINE SCREEN:** 1501 pi (1331 minimum)

**FONTS:** Postscript fonts only. True Type Fonts are not acceptable. All printer and screen fonts must be included in files.

Full Page	8-3/8" x 10-7/8"
Half Page Horizontal	8-3/8" x 5-7/16"
Third Page Vertical	2-3/4" x 10-7/8"
Trim Size with Full Bleed	8.5" x 11"
Final Trim Size	8-3/8" x 10-7/8"

Must be in TIFF or EPS format in CMYK (NOT RGB) at 300 dpi resolution (high-resolution). Please perform all color corrections in Photoshop before you import into any application.
